The Green Township School District is currently in the process of drafting a revised Health and Physical Education Curriculum that will be aligned to the updated health and physical education standards. The updated standards can be found at this link.

There has been a great deal of question and concern raised about the implementation of the new standards. As stated by the NJ Commissioner of Education Dr. Allen-McMillan, each local school district is tasked to create their curriculum and receive approval from the local Board of Education. As part of the revision process, the Green Township School District is seeking feedback from our stakeholders on thoughts, concerns, and questions about the revised standards. There will be multiple opportunities for public feedback on the revised curriculum as follows.

Wednesday, 8/3/22 at 7 pm via Zoom	A virtual meeting will be held for parents and teachers for the purpose of posing questions, raising concerns, and sharing perspectives about appropriate Health and Physical Education curriculum.
Thursday, 8/4/22 to Thursday, 8/11/22 via Google Survey	A survey will be sent out to all parents and teachers to allow for additional input. This provides an important opportunity for anyone who wants to share their thoughts and is unable to attend the meeting on 8/3.
Wednesday, 8/17/22 at 7 pm via Board of Education Meeting	A presentation on the new standards will be made at the Board of Education meeting. Additionally, the feedback collected from the input session and survey will be reviewed.
Wednesday, 9/21/22 at 7 pm via Board of Education Meeting	A presentation on the new revised curriculum will be made at the Board of Education meeting for consideration of feedback and/or approval.
